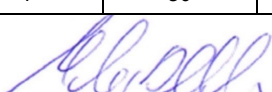
We hereby declare that L10 Expectancy: 70,000 hours minimum@ fan rated voltage and the temperature of 40°C, According to the equation for Weibull distribution, $MTTF = 7 \times L10 = 490,000$ hours. And we rely on a zero failure Weibull test strategy and accelerated testing technique, to determine the total test time (t) for verifying the above life estimation by the equations,

$$t = 1.036 \times MTTF \times [(Br;c) \div n]^{0.91} \div AF, \text{ and } AF = 2(TS-TU)/10$$

Where, (Br;c) is Poisson distribution factor with the failure number of r equal to 0 and the decimal confidence level of c equal to 0.90(90%), and
